Labor Management 02/23/2023

- Hazmat physicals
 - Currently, SFFBT puts everyone through a physical that is very thorough
 - We would prefer that our members only do one physical, and the SFFBT physical is better quality
- New paramedic contract with City
 - L29 asks: do we have newly-hired employees sign an agreement saying they will serve as a medic for a certain amount of time?
 - Right now, new employees are not signing a contract.
- Vacation accrual rates for returning employees
 - Timebank is involved. Randy wants confirmation that rates are correctly accounted for
 - Admin will make this right for the ones that are owed time
- Promotional worksheet updates
 - Admin assignments are now 18 months; promotional worksheet needs to be updated
 - Discussion was had, and both parties agree to modify the language on the promotional worksheet and workbook to say that administrative assignments receive .5 points for each 6 months served in the position up to a maximum of 2 points.
