3. Presentations

Mayor Lisa Brown presented and took questions from the membership.

4. Approval of the Minutes

- Reading of the minutes was dispensed as they were emailed to all members.
 - The minutes were approved.

5. Swearing In

6. President's Report

Eboard Meeting:

• WSCFF 9th District Representative Report

- Boeing FFs appreciated our support, and they are back to the negotiating table.
 - Picketing has been effective in slowing the operations of Boeing and sending a message.
 - Ryan Davis and Sean Doyle are organizing Local 29 participation each Thursday, and all of those interested will travel to participate on the picket line at Boeing in Moses Lake. Watch for an email with details.
 - June 2027 WSCFF Convention will be hosted in Spokane. All IAFF locals in the area will be contributing to make this a success.

Labor Management:

■ The April L/M meeting was canceled.

New Business from Eboard:

- Discussion was had on L29's support for the upcoming public safety levy.
 - There was a question from a member about how minimum staffing affects the discussion about the levy and its passage.
 - A member had a question about how many members could be cut if the levy fails. We don't know for sure how many and where the cuts would come from.
 - The vote for this levy has a 50% threshold for passing.
 - There was a question from a member about ARPA funds and whether these would be available to cover the deficit. These funds have already been allocated, but if funds get freed up, this money could come our way. Chief O'Berg has done a great job of presenting our needs so that the City is aware.

- A member asked what our plan is for marketing to get the levy passed. The committee is looking at bringing in marketing professionals and doing a good job of presenting this to the public. This will be a coordinated effort (including PD), not just us. The key item is ensuring that the public understands the cuts that will take place to police and fire personnel if this doesn't pass.
- There was a question from a member about how long the levy funds would last. This is a levy lid lift, which means that for the next \$1 of taxing authority, it will be dedicated to public safety. It is a lifetime levy, but over time, the effectiveness of this money becomes less and less.
- A member asked if this gives more weight to the discussion that we should become an RFA. The passage of the levy does not change the exploration of an RFA as a long-term option.
- A member asked when the levy could be run again if it doesn't pass. If this doesn't pass, we won't be worried about when it runs again, we will be worried about how to function with a lot less money. SFD will get the majority of the levy dollars if it passes.

Politics

- Marcus Riccelli's opponent dropped out, so he is running uncontested and has a clear path to the Senate.
- Molly Marshall is running against Al French. She has been active in the community for us, aggressively pushing for 1710 standards. She will be asked to visit our next e-board and union meeting.
- Chris Jordan is also running uncontested.

L29 Survey Results

- Survey results were reviewed with the e-board, and these will be discussed by Marler as he travels around for station visits.
- LODD Henry Maynard (07/25/1909) Headstone
 - Henry Maynard's family asked for help purchasing a new headstone because the current one is in poor condition. There was a motion passed at e-board to support the Maynard family by purchasing a new headstone.

Paramedic promotional point discrepancy

 The current promotional worksheet currently give 1 point for a paramedic degree, but no point for certification. Discussion about the recommendations from the L29 promotional committee will be resumed once Chief Reding is settled into his new position.

Picket Notification

- There was concern about the timeliness of messaging regarding picketing with UFCW. The Local did message on social media, but the email notification to the membership was behind by 2 days.
 We will try to do a better job in the future at getting these messages out in a timelier manner.
- Bloodwork CT Calc./Lipoprotein A (Walla Walla)
 - Staggs asked about a test that may have been an early detection instrument for the condition that resulted in the death of the Walla Walla member. Randy will ask about the Hilvers clinic performing these tests.
- Conditionally Approved C&B Received from IAFF
 - The updated C&B as amended by the IAFF will be sent to the membership for a referendum vote on the changes.
- 2024 L29 Goals and Priorities
 - Discussion was continued on Local 29 goals and priorities at today's e-board.

Station Rep. Reports

- Golladay (2&4)
 - Paycheck issues continue to be a problem. These should continue to be taken up the chain of command. If members receive an incorrect answer or the issue isn't resolved, the information should be sent to Randy.
 - There was a question about why we have to go through the chain of command. One of the goals of this process is to include fire Admin so that they understand the problems and remain aware of whether they are being addressed.
 - Additional discussion was had on specific paycheck issues.
 - Paycheck issues are again on next week's Labor Management agenda.
- Walker (Prevention/SIU/1) Reporting for Price (Relief/Probationary)
 - There was a question from a member about adding items for negotiation. We are done accepting items for negotiation, and there will be a special meeting with the membership to communicate what will be taken into contract negotiations.

 AC at station 1 continues to be a problem. Randy spoke with City official about \$700k from unspent ARPA funds that could be used specifically for HVAC replacement.

Staggs (8/15/18/Training/MSO)

Nothing to report.

Austin (13/16/17)

- There was a question from a member about long term disability and associated retirement. We all pay into long term disability as a benefit from WSCFF. The first step if you think you will be off for an extended period, start the paperwork early because there is a lag time in the processing. Every member's situation will be different.
- There was a question about paramedic drafts for vacancies on BLS rigs. We do not know how the potential new system could work.
- There was a question about why we have not had call back chiefs on recent fires. Callback is no longer in the SAFO contract. The Tour Commander is now covering the things previously done by the SAFO chiefs, including callback of crews during a multi-alarm response.

• Davis (7/9/11/14)

- Question about C shift FLSA period break. C shift essentially ends up with a 56-day FLSA period instead of the 28-day cycle that is specified. This is being forwarded to Labor Management as a potential grievance.
- Question about the levy and potential reductions in staffing. This was covered earlier in the meeting.

Newman (3/5/6)

 One member had a question about SFFBT billing when dependent children pass the age of 26. Members should keep an eye on their withdrawal amounts to ensure they are accurate and report to the Benefits Trust if there are issues.

7. VP Report

• <u>Clothing/PPE Committee</u>

• Grievance Committee

- SAFO grievance is going to arbitration.
- 1 potential grievance put on the Labor Management agenda regarding the C-shift FLSA cycle.
- 1 potential grievance regarding time bank payouts that did not include add-topays.
- Our labor attorney is helping to develop an internal grievance policy for the Local that will help guide the e-board on processes. There is also a grievance cheat sheet that will go out to the membership to provide guidance as well as an electronic form on the new website.

• Safety Committee

- Field testing particulate hoods.
- Airport response plan. AC Williams said that Admin is discussing with the airport board.
- Extractor calibration is off the list of old business because they discovered no evidence of failure from the new extractors.
- Updating SOGs for violence against responders.
- Radio channels SREC has made updates and put SRMA channels back onto our portables that were previously removed. Shared radio channels with PD will likely be discussed more as the RTF plan gets revised.
- Tiller seat on L4 hasn't been fixed yet.
- The department hydration plan for members on scene was discussed. Rigs will have igloo coolers instead of bottled water. The committee is looking into stainless steel, but in the meantime, the plastic igloo coolers have been purchased.
- Safety is working with Peer support to develop a handout for quick and easy access to all relevant resources.
- Williams brought up having an accident review as part of each committee meeting to evaluate if policies or procedures need to be changed. Names are redacted from the reports, so the motive is just to review incidents and determine how to eliminate them in the future.

SOG Committee

 Has not met yet. Both Chiefs O'Berg and Neiwert were on board with involving the committee during the process of moving to the new Lexipol system.

• Peer Support

o Inpatient referral flowchart has been referred to Admin and City Legal.

- o If someone is believed to have an acute risk of suicide or homicide, they are referred. Golladay brought up concerns over who has the training and authority.
 - This hasn't come to Local 29, so Randy will contact AC Williams and ask that this be discussed with the Local.
- King is working on a Peer support handout for the job also.
- Lee sent the proposed Peer support policy to the board for review. Discussion
 was had on how time is compensated. The board suggested that language be
 changed to say that Peer support members are compensated at their OT rate.

Public Safety and Health Committee

- Chief O'Berg presented:
 - Current relief pool of 24; 44 is what they're shooting for.
 - Still recruiting for an IT supervisory analyst.
 - Staff BC is still awaiting approval through the Civil Service process.
 - Currently 24% lower than last year's OT cost.
 - Total incidents are down 400 calls from last year.
 - There was a question about where these numbers come from. We do not know, but Forbes has been working to clean up the data that we receive.
 - Overdose data was presented, and overdoses occur consistently throughout the day.
 - Communications within the department was discussed.
 - Nurse navigation line was expected to go live in June. No cost to the end user for transportation to urgent care. This system is run by AMR with a call center in Texas and handles low-acuity calls.
 - Chief O'Berg presented strategic initiatives that included expansion of the CARES and BRU program.
 - Discussion was had on the potential of a 1-year building moratorium in the Latah area due to wildland urban interface concerns.
